The Fire Chief shall acknowledge that all individuals of their department participating in Live Fire Training have met the minimum requirements as outlined below:

- 1. Completed a minimum 64-hour Basic Firefighting course developed by the Tennessee Fire & Codes Enforcement Academy or equivalent (per Tennessee Code 4-24-112) within the past 3 years, if the candidate has never completed a Live Fire Training Course, and proficient in the following topics (per NFPA 1001):**

- Firefighter Safety and Health
- Fire Behavior
- Personal Protective Equipment and SCBA
- Portable Fire Extinguishers
- Search and Rescue
- Forcible Entry
- Ladders
- Ventilation
- Water Supply
- Fire Hose, Appliances, and Streams
- Fire Control
- Loss Control

If individuals have previously completed the Basic Firefighter Course and Live Fire Training, there are no time restrictions to complete the live fire training again.

- 2. OSHA Regulation 1910.134 and NFPA 1500:**

- Individuals shall not wear beards or other facial hair that **MAY** prevent a complete seal between the facepiece and the individuals face.
- Individuals shall not wear glasses that extend between the facepiece seal and the individuals face.
- All participants listed on this form have been fit tested as per OSHA 29 CFR Part 1910.134 for the respirator to be used during the live fire training event.
